"From the Pastor"

This month is Stewardship month. Last week I talked a little about what is Stewardship. This week I want to talk with you about a related stewardship theme: **Planned Giving**.

Planned Giving is a way of expressing your faith in a special way — through a careful considered gift to the church. A planned gift is one of the best ways for you to help the church further Christ's work. Your gift can come from many sources. A planned gift can be assets, such as securities, property, insurance policies and other savings that you own, or have earned, or have inherited. Why is planned giving important? It's good stewardship. It is faithfully and wisely managing our gifts, including assets to serve God. Planned giving can help you achieve financial security. A planned gift can be an important part of your total plan for living and for your overall financial planning. Spiritually, a planned gift is your personal, ongoing response to God and a way you choose to carry out the Gospel message. Financially, a planned gift is an effective tool for preparing for the future.

Everyone should consider planned giving: young people, single people, married people, people with children, people whose earning is at its peak, retired people, those concerned with the ultimate disposal of their assets.

A planned gift is a valuable tool. It can help you; meet your church's goals, perhaps targeting your gift to a specific need that the church is striving to fill; provide security for others; honor a friend or loved one through a memorial or a bequest; plan your future; reduce taxes; fulfill your wishes after your death; reduce worry, especially if your gift assets can be managed by an investment manager, which saves you worry, bookkeeping efforts, and money.

Planned giving can help your church. It can help carry out the church's ministry to

Planned giving can help your church. It can help carry out the church's ministry to others, providing hope to the poor, the sick, and the needy. It can continue Christ's work in all areas of life that are of important to Christians. It can carry out mission in the world, bringing the Gospel to people, communities, and nations. Your gift could be put to work to support evangelism, help finance mission programs, fight illiteracy, help the aged and people with disabilities, maintain your place of worship, care for the sick, support hunger and nutrition programs, establish scholarships or support educational programs. Our church has a Memorial Fund, a Designated Fund, and an Endowment Fund where your planned gift can be utilized for the work of the church.

The Endowment Fund is a special fund where your gift will keep on giving long after your death. Your gift will be invested and only the earnings (interests) will be spent in designated areas established by our Endowment policy, which was

approved by our congregation. There are several kinds of planned gifts from which you can choose that best suits your goals and your financial situation. There is a **revocable trust** where you can give now but change your mind later in case your situation changes. There is an annuity; you receive a fixed amount of income each year, and the church receives the remaining principal at some future point. This type of gift could offer substantial tax savings. You can give and receive a variable income through a **Unitrust**. You receive a percentage of the trust's value as determined each year. This trust also offers substantial savings too. You can retire and give unused funds, naming your church as the beneficiary of any funds left over from your company pension plan, IRA, or other private retirement fund. You can give generously at minimum cost through a gift of life insurance. You can convert an existing policy into a gift forth church, if you no longer need the coverage. Or you can give a new policy or one that is partially paid. You can give to the church in honor of someone through our memorial fund to support a valued program or goal of your church. Also, you can make a gift effective upon your death through your will. A will is an important gift-giving vehicle. You can use it to provide for your heirs

and to make a charitable gift with lasting importance.

How much you give is not as important as the act of giving itself. You will need to take into account both spiritual and practical considerations to determine how much to give. Assess your values, look at your financial situation, discuss options with your financial advisor and our endowment fund committee and pastor.

Planned giving is good stewardship.
